These and other related matters have recently become a hot topic in the context of biometric technologies, which are ubiquitous in personal, commercial, and governmental applications.

Biometrics represent an integral component of many surveillance, access control and operational identity management systems, thus directly or indirectly affecting billions of people all around the world.

A white paper will be published based on the outcomes of the virtual events.
